Declaration of Interests Policy

Companies (Guernsey) Law 2008

In accordance with the Companies (Guernsey) Law 2008 and recognized good practice, all Directors or members of the Executive Committee are formally required to declare all their possible conflicts of interests in their capacity of Directors or members of the Executive Committee of the Guernsey Darts Association (2010). Details are also sought for immediate family (i.e. spouse, partner, children and parents) as potential allegations of conflict of interest may also extend to the influence of close relatives.

This also is applicable to items on an agenda which are openly discussed at each Guernsey Darts Association (2010) Board or Executive Committee meeting. The agenda will include a mandatory, standing item that Directors or members of the Executive Committee will be asked to declare any possible conflict of interest at the start of the meeting. Any such declaration by any Director or member of the Executive Committee at that time will be noted in the minutes of each meeting.

The process for such declaration is for the individual to complete and sign a Declaration of Interest form on appointment to the Board of Directors or Executive Committee of the Guernsey Darts Association. This is to be renewed annually, at the first Board or Executive Committee meeting each year which takes place following the Annual General Meeting.

Any changes to the circumstances should be recorded immediately with the Company Secretary and the form updated in accordance with said changes. These forms will be kept by the Company Secretary. A copy will be kept and be made available for inspection at the registered offices of the Guernsey Darts Association (2010).

The information to be noted should include the following:

- (a) Full details of any membership or involvement with sports clubs, governing bodies or sports related organisations which are either current or have expired within the last five years:
- (b) Commercial interests in companies owning, operating or providing sports facilities, or the supply of goods or services which the Company and / or its members may purchase; and
- (c) Any other information that may be of relevance.
